## The changes refer to the following:

- 1) The "Current Fee" of the Mutual Funds in the "Key Investor Information Documents" (part 3) was updated with data of the full fiscal year 2014 (ended 31/12/2014).
- 2) In the "Past Performance" in the "Rulebook and Prospectuses" (article 6 of the Prospectus) as well as in the "Key Investor Information Documents" (part 4) a graph was attached.
- 3) The management fee of the investment compartment "GMM BEST SELECTION BALANCED FUND" of the Mutual Fund "GMM FUNDS" was decreased from the 2.5% to 1.5% in the "Rulebook and Prospectus" (annex 8, part 5 of the GMM FUNDS Rulebook).
- 4) The maximum entry and exit fee that an investor may pay during his/her subscription/redemption of units of Mutual Funds managed by GMM Global Money Managers Ltd., was decreased in 6 of these funds.
