A) In the document "Key Investors' Information Document":

In section 5 "Practical Information" the "Risk Management" function has been removed from the ones that the Management Company has outsourced to third parties, based on written outsourcing agreement.

B) In the document "Rulebook and Prospectus":

- In the Prospectus the phrase "The Risk Management Division operations have been outsourced to Charterhouse Fiduciaries Ltd whose registered offices are in Nicosia" has been removed.
- In the Prospectus the phrase "The Risk Management function of GMM Global Money Managers Ltd. has been assigned to Mrs. Vassiliki Dimitriadou, an employee of the company" has been added.
- In the Prospectus of UCITS "GMM FUNDS":
 - a) In paragraph 1 the name of the UCITS "GMM Short Term Bond Fund" has been added in the list of UCITS managed by Mr. Nikolaos Kaltsogiannis and
 - b) At the same time the phrase "Ms. Vasiliki Dimitriadou is the administrator responsible for monitoring the following Mutual Fund Investment Compartments: GMM SHORT-TERM BOND FUND" has been added.

These amendments are effective as of 8.12.2018 in line with the decision of the Cyprus Securities and Exchange Commission taken at its meeting on 30.11.2015

The fund's unitholders are entitled to request that their units be redeemed within 3 months of the date on which these amendments to the Rules were notified to them, i.e. by 14.03.2015, in accordance with the provisions of the Rules as they were prior to being amended.
